

Contest Rules

'How many bottles of wine are there in the wine cellar?'

1. Organiser

2. Participation period

The competition begins on 10 March 2026 and ends on 31 March 2026.

Entries outside this period will not be considered.

3. Participation

Participation is exclusively via Instagram and Facebook.

To participate, the following conditions must be met:

- Follow the hotel's Instagram or Facebook account.
- Like the competition post.
- Estimate the number of wine bottles in the wine cellar in the comments.
- Tag a person with whom you would like to redeem the prize.

Participation is free of charge.

Persons aged 18 and over who are resident in the EU are eligible to participate. Hotel employees and participating agencies are excluded from participation.

Only one entry per person is permitted. Multiple comments will not be considered.

4. Prize

The prize is:

2 nights for two people in April 2026

(1 double room incl. Breakfast from 12th till 29th of April 2026)

The exact date is in April 2026 and will be agreed in advance with the hotel and subject to availability.

The prize is non-transferable and cannot be exchanged for cash.
